Conditions:

- a) Wheeling of energy is subject to availability of quantum of energy available for wheeling in the account of generator including the actual generation in the month of **November_2023**.
- b) The above charges should be collected as per the KERC Tariff Order and its Amendments from time to time
- c) The wheeled energy to be treated as FIRST CHARGE on the total consumption by the individual HT consumers and only the balance portion of the consumption is to be billed as per the applicable tariff.
- d) The consumer having outstanding arrears to KPTCL/GESCOM will not be eligible for availing wheeled power unless special permission from the competent authority is produced.
- e) This energy does not require billing as it is allotted from the energy generated by the above Company.
- f) This energy does not attract fuel escalation charges.
- g) This energy is however subject to verification by audit.
- h) This wheeled energy allotted to does not attract any additional 2 MMD charges.
- i) The energy as per this office OM may be wheeled to those industrial consumers for whom GESCOM has permitted to pay arrears in installments or at a later date and paid in time.
- j) However, energy as per the above OM should not be wheeled to installations having arrears for which GESCOM has not permitted installment facility.
- k) As per GOK vide Notification No. EN 106 EBS 2018, Bengaluru, dated 19.07.2018 from Energy Department, 20paise per unit shall be levied and collected as electricity tax on captive consumption of electricity generated by captive power generating plant at the respective O&M sub divisions and remitted to the CEIG, GOK, Bangalore. Order will be effective from 19.07.2018.
- l) **Note:- Wheeling OM will not be placed without further notice, if the OA Consumers and Generator did not install "The AMR Compatible meters and should have AMR facility for data communication" as per Hon'ble KERC Order dated 31.07.2023.**
